

INTRODUCTION

TO COMPLETE THE BAND TERMINATION, THE EXTENDED BAND TAB MUST BE ROLLED OVER THE BUCKLE. FOR THIS PURPOSE, THE DBS-RO3 ROLLOVER TOOL IS ADJUSTABLE FOR BACKSHELLS RANGING FROM 1/4 INCH TO 2-5/8 INCH DIAMETER.

SET-UP


TO CHOOSE THE PROPER SETTING, SELECT THE TRACK THAT ALLOWS BOTH THE BACKSHELL TO FIT INTO THE PLIER JAWS, WHEN OPEN AND THE ROLLOVER MECHANISM TO CLOSE COMPLETELY AGAINST THE UPPER JAW (LEAVING NO GAP). THIS ADJUSTMENT CAN BE DONE SIMPLY BY RO—TATING THE TOOL APPROXIMATELY 90° FROM THE BUCKLE AND CLOSING THE JAWS TO INSURE THAT THE REQUIREMENTS STATED ABOVE HAVE BEEN ACHIEVED (SEE FIGURE 1).



WARNING: DO NOT USE EXCESSIVE PRESSURE WHEN CLOSING THE ROLLOVER TOOL ON THE BAND. THIS MAY CAUSE DEFORMATION OR CRACKING.

OPERATION


AFTER INSURING THAT THE TOOL HAS BEEN PROPERLY SET, INSERT THE EXTENDED BAND TAB INTO THE ROLLOVER MECHANISM MOUNTED ON THE UPPER JAW. THE EXTENDED TAB MUST BE FACING THE FRONT OF THE TOOL AS SHOWN IN FIGURE 2.

TO COMPLETE THE ROLLOVER, SIMPLY SQUEEZE THE HANDLES UNTIL THE ROLLOVER MECHANISM IS CLOSED COMPLETELY AGAINST THE UPPER JAW (LEAVING NO GAP) AS SHOWN IN FIGURE 3. OPEN THE HANDLES TO REMOVE THE TERMINATED BACKSHELL ASSEMBLY.
